

## FREQUENTLY ASKED QUESTION



1. What height should my dog be in?

- a. This is a Fun Match. You should run your dog at the height that you practice at. You can run at the height that you and your dog are comfortable at. Talk to your instructor, they will be able to help you. The chart below will help you determine what height your dog jumps at an AAC sanctioned trial.

Dog Height at withers	Regulars	Special*	Veteran*
Less than or equal to 12"	10"	6"	6"
Greater than 12" & less than 16"	16"	10"	10"
Greater than 16" & less than 21"	22"	16"	16"
Greater than 21"	26"	22"	22"

\*a Specials dog is one that for what ever reason cannot comfortably jump at its' regular height

\* a Veterans dog is one that is 5 years or older and needs the lowered jump height and the extra time

swing and to ensure your dog and valuables are secure.

## SPECIAL INFORMATION

Although aggressive dogs are not allowed to be at an agility trial we will be issuing bandanas to any dog that have 'space issues' (are reactive to other dogs or humans). Bandanas will be provided by Dogwood Pacesetters and will be given to any dog whose owner has requested one or to any dog that the organizers feel need to wear one.



**Note:** Just because your dog is friendly, don't assume that others are. Watch your dog and keep him/her on a short leash when walking around or just chit chatting with fellow competitors etc.
