MY NEW RABBIT HOUSE

This is my new rabbit building I use for rabbits going to shows. It is a 12 foot by 20 foot car port. I have 24 18 inch by 24 inch cages in it, one rabbit to the cage. I put them in these at about 10 to 12 weeks old and they stay there until I either sell them or I breed them. Both ends are closed with the sides being open for draft. In the winter I close the north side with heavy plastic, the south side stays open. I also have 2 100 watt bulbs in it for light.

The cost of the building and cages was around \$1200 but it works real well. It also sets in a woods which helps in the summer heat.

Requirements for Receiving a Scholarship

- A. The recipient must have been a member of the National Florida White Club for at least three (3) years prior to submitting an application.
- B. The applicant must be a graduating high school senior or in their first year of college.
