I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION, HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

[1] (Variety) If you are entering a dog of a breed in which there are varieties for show purposes. please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in., but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

[2] A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on the entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

ATTENTION EXHIBITORS

CATALOG ORDER: As far as is practical, entries will be arranged according to jump height in ascending order.

MOVE-UPS: There will not be move-ups after the closing date.

ENTRY FEE is \$27 per entry (which includes the AKC recording and event fees). Entries will not be accepted if received without fees. Make checks payable to **CRDTC** and send to: Margaret Stubbs, Trial Secretary, 12 Meadowbrook Road, Weston MA 02493

TELEPHONE, telegraph, *unsigned*, or conditional entries cannot be accepted. Entries not on official AKC Entry Forms and **entries without the Agreement attached are not acceptable**.

ENTRY FEES will not be refunded in the event of a dog being absent, disqualified, or excused by a Veterinarian or Judge, or barred from competition by the act of the Trial Committee.

NO ENTRY FEE will be returned if the show cannot be opened or be completed by reason of riots, civil disturbances, fire, an Act of God, public enemy, strikes or any other cause beyond the control of the CRDTC.

BITCHES IN SEASON: A refund will be made for a bitch that comes into season after the Closing Date, provided the request is accompanied by a veterinarian's certificate and is received by the Trial Secretary prior to the start of judging.

OWNERS ARE RESPONSIBLE for errors in the making out of entry forms, whoever may make such errors. No entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.

JUDGES WILL NOT WAIT for any dog holding up a class. The owner or agent of each dog is responsible for the presence of their dog in the judging ring when their class is called. Dogs need to be present only for scheduled judging. **Only dogs entered in the trial are permitted at the trial site.**

DUE TO SPACE LIMITATIONS crating area and personal chair space will be limited. Please help us use that space as efficiently as possible.
