- 1,000 Homes 500 SF BI-PV Solar Systems on South-Facing Roofs in 100 Counties of Kansas
 - 200 Commercial Buildings Average 2,500 SF BI-PV Solar Systems in 100 Counties of Kansas
 - House Bill 2018 written by Representative Tom Sloan 2003 for *Renewable Cooperatives*
 - Requires 5 *or more* people to establish renewable cooperative must commit to generate *at least* 100 kWp
 - 100 kWp = 15 Homes with 5kWp generators and 1 Commercial Building with 25 kWp generator
 - 1 to 100 K-SEC Cooperatives in 100 Counties + Solar Buildings Registry = 1,000 MWp BI-PV Electricity

- 72.5% of electricity consumed in Kansas today is generated by coal-fired steam plants.
 - Kansas ranks 18th in nation for coal *mercury* toxins. Westar's Jeffrey Plant 5th in nation for mercury.
 - In 2005 a 40% increase in coal-fired plants in Kansas was proposed by five entities.
 - Half were preliminarily approved including KCP&L coal plant in Weston, Missouri.
 - Two 600 MWp coal-fired plants in Holcombe, KS would pollute KS to provide Colorado electricity.
 - Where is Natl. Renewable Energy Laboratory, Rocky Mountain Institute, Lovins, etc???
 - Mass official consumer complaints can stop these power plants ~ democratically.
 - Monitor Energy Agency Proceedings at Kansas Corporation Commission website.
 - DEMAND ALL NEW COAL PLANTS BE PUT TO PUBLIC VOTE BEFORE APPROVAL!
