My name is Badescu Manuela Delia. I live in Baia Mare, Romania and I have a daughter, Stefania, who is a 19 year old, 1st year student at Med School. After a detailed medical checkup; Stefania was diagnosed with neurinom acustic, located on the right (pontocerebelos) angle, so it is a third degree benign tumour that is already very big 31/25/30 mm. This indicates the necessity of immediate surgery. The tumour is growing and slowly presses the cranial nerves causing several symptoms such as damaging the hearing, facial paresis, terrible headaches, balanced (equilibrium) problems and double eye sight . For now Stefania's hearing was damaged only on the right ear in proportion of 30 to 40%.

The surgery is a very difficult one and can only be proceeded in a clinic in which there are interoperative monitoring systems of cranial nerves, a device that does not exist in Romania. Here, for this type of disease the surgeries have a 50:50 chance of success. Because of the risk of surgery in Romania is so high we started to look for a clinic abroad that could offer us a bigger chance of success and so we found one. The biggest chance that my little girl can continue smiling is offered by clinic in Hanovra (Germany), the neurosurgery clinic of the renowned neurologist Dr .h.c. M Samii of the International Neuroscience Institute, but the cost of the operation and of the medical care is 35.000 Euro, as the clinic itself confirmed us.


At this time I do not have this amount of money and I honestly do not think I can raise this amount in such a short period of time and we cannot benefit of the E 112 form of the National House of Health in Romania as we could proceed the surgery here, even though the chances of success are so low.
