William Hetherington (186155) was considered for parole during the week of August 14, 2000. Following consideration in Executive Session, the Parole Board voted to deny parole for a period of 24 months. One of the reasons stated in the parole denial was that "The prisoner has a criminal history including a weapon or weapons". The reference to the weapons was deemed inaccurate in a previous Parole Board Notice of Action. 


Please cast your vote below:




