ORDER SETTING ASIDE SHOW CAUSE ORDER AND REQUIRING RESPONSIVE PLEADING

Petitioner William Hetherington, a state prisoner currently confined at the Parnall Correctional Facility in Jackson, Michigan, has filed a petition for a writ of habeas corpus pursuant to 28 U.S.C. § 2254 alleging that he is incarcerated in violation of his constitutional rights. The habeas petition, filed by counsel, states that Petitioner was convicted of first-degree criminal sexual conduct for the rape of his wife following a jury trial in the Genesee County Circuit Court in 1986. He was sentenced to 15-30 years imprisonment. Petitioner made various unsuccessful attempts to pursue an appeal as of right with the Michigan Court of Appeals from 1986 through 1993. *See* Brief in Support of Petition, pp. 18-22. Petitioner apparently did not seek leave to appeal with the Michigan Supreme Court. *Id.*

On January 26, 1998, Petitioner filed a motion for post-conviction relief with the trial court, which was denied on March 31, 1998. *See* Petition, p. 3; Exh. 46. The trial court denied Petitioner's motion for reconsideration on May 20, 1998. Petitioner filed an amended application for leave to appeal with the Michigan Court of Appeals, which was denied. *People v. Hetherington*, No. 218462

IT IS FURTHER ORDERED that, as an initial matter, Respondent shall file a brief addressing the statute of limitations issue by MARCH 22, 2001. A separate index listing the materials being submitted shall also be filed.
