## **1.Wamba Fund.**

Wamba money in Uwaba Account strangely shows that has been arrived in UWABA account since February 9<sup>th</sup> 2009, according to the statement Jongo got from bank, total amount of money deposited in Uwaba account from Wamba Fund is Tsh. 3,787,199.77. From the next meeting we will start to implement continuation of Wamba project.

#### **4.WHO CONFERENCE IN BRUSSELS;7<sup>th</sup> -8<sup>th</sup> May 2009.**
