## Agreement

IN CONSIDERATION of the mutual terms and conditions contained herein, **E'OLA® International (E'OLA)**, and Distributor agree as follows:

- 1) The Distributor avows he/she is at least 18 years old.
- 2) Distributor will be an independent contractor, responsible for their own business and not an employee or representative of **E'OLA**. Distributor is responsible for the payment of all Federal and State self-employment taxes and for obtaining any necessary licenses.
- 3) Distributor understands that no purchases are required to become an **E'OLA** Distributor except a \$75 purchase of products and the enrollment fee for an **E'OLA** distributorship. These may be optional in some states (call **E'OLA's** Application Processing Department for information).
- 4) **E'OLA** agrees to make quality products available to Distributor.
- 5) This Agreement may be transferred or assigned by Distributor only upon written approval from **E'OLA**.
- 6) This Agreement shall be deemed accepted by **E'OLA** upon issuance of a Distributor Kit to Distributor.
- 7) This Agreement, the Policies and Procedures and Compensation Plan (both included in the Distributor Kit) contain the entire understanding of both parties.
- 8) This Agreement shall be governed by the laws of the state of Utah.
- 9) Distributor may purchase products from **E'OLA** at the current wholesale prices.
- 10) All products purchased by Distributor are subject to the warranties and disclaimers applicable to the products at the time of purchase.
- 11) Distributor agrees to use their best efforts in the retail sale of **E'OLA's** products. Distributor understands that **E'OLA's** products are not represented as having any medicinal value and that he/she is not authorized to make any diagnosis of any medical condition, make drug-type claims for or prescribe **E'OLA's** products to treat or cure any disease or condition of man or animal.
- 12) Any oral representation made by Distributor to induce any person to become an **E'OLA** Distributor, contrary to this Agreement, the Policies and Procedures and Compensation Plan (both included in the Distributor Kit), is expressly disavowed by **E'OLA**, and may not be relied upon by Distributor.
- 13) Distributor agrees to indemnify and hold harmless **E'OLA** (including its officers, directors, employees and agents) against any claims, liabilities, obligations, expenses (including attorney's fees) or damages arising out of any misrepresentation made by Distributor in connection with any of **E'OLA's** products.
- 14) **E'OLA** may terminate Distributor at any time if Distributor breaches this Agreement or engages in any conduct that may bring disrepute upon **E'OLA** or which is in violation of any law or government regulation or ordinance.
- 15) Distributor acknowledges that he/she is not currently an **E'OLA** Distributor and has not been a Distributor within the last six months or a Director within the last year.
- 16) Distributor acknowledges that he/she has already read the Policies and Procedures manual and agrees to abide by its content.
- 17) Distributor acknowledges the Policies and Procedures may be amended and updated by **E'OLA** from time to time and Distributor agrees to abide by all current Policies and Procedures.
- 18) All lists of the Company's Distributors and customers are confidential trade secrets and the property of the Company. Distributors agree not to disclose such lists to anyone other than an authorized officer of the Company.

## Quick Start

- 1) To be a Quick Start Distributor, you must sign up for the program at the same time you sign up as a Distributor.
- 2) Quick Start Order Returns will be refunded minus the 10% restocking fee, 20% for bonuses paid, and Q.S. bonuses #1 and #2.
- 3) Quick Start Distributors cannot send or receive volume transfers during their first 45 days of activity.
