#### Friends of Woodmont to Explain Role at Woodmont Center

Carolyn Hottenstein, co-chair of the Friends of Woodmont, will explain the group's activities as a support group for the Community Integration Center, contracted to Service Source, at the Woodmont Center. Brenda Jones directs the day program for about 40 intellectually disabled and special needs adults. All participants in the day program have graduated from the Arlington Public School system and are considered employees of Service Source as they work on directed activities.

Caroline Hottenstein will be requesting coordination with the Woodmont Civic Association in urging the county's Parks and Recreation Department to increase the care level of the grounds of the Center when the construction is completed.

#### **Real Estate Corner**

Submitted by Bob Kenney – Woodmont resident, Realtor, Graduate of Leadership Arlington (Class of 08 – Worth the Wait), and V.P. of Woodmont Civic Association.

Arlingtonians often ask me if the Arlington real estate market is holding up better than the rest of the region. Is it? And if so, then by how much?

Let's look at the numbers for October, 2008. Overall, Northern Virginia saw an 18% drop in the average sales price of a home (condo, townhouse, single family) when comparing sales in October, 2007 to sales in October, 2008. Arlington, however, saw only a 4% decline. In Arlington, the biggest decline was in the price of townhomes, while the price of single family homes held up quite well. In our zip code 22207, the average sold price actually increased by 4% using the same (October) comparison.

If we look at our own neighborhood, Woodmont had 16 homes change owners in 2008 (16 in 2007) per MRIS. The most expensive home sold this year was the manor house located at 2500 25<sup>th</sup> Street. N. It sits on 7.4 acres sited above the Potomac River and sold for 4.5 million. Excluding this property, the average sold price in Woodmont this year for a single family home was \$1,116.000 (\$1,183,000 in 2007). The lowest sold price for a home was \$720,000 (\$660,000 in 2007) and the highest sold price (excluding 2500 25<sup>th</sup> Street) was \$1,950,000 (\$2,350,000 in 2007). Overall, our neighborhood is showing strength as many believed it would. You cannot say enough about location, location.

It sure does not hurt either that our community as a whole has been recognized nationally for its smart growth over the past 10 years. Recently, Clarendon and Wilson Boulevards were named one of the top 10 great streets in the U.S. by the American Planning Association – quite an accomplishment!

Have you been wondering lately about some of those development sites that you see around the

county? Did you know that it looks like the CVS and Sala Thai restaurant at 10<sup>th</sup> Street and Washington Blvd. will actually be torn down soon (the sign still says coming in Spring, 2007). A mixed use building of retail and residential units will be built. The land that has been cleared behind the Wendy's at Courthouse (goodbye KFC and Taco Bell) will begin construction in the coming months. While I had first heard that this would be all retail shopping, it is now reported that the project will include 141 residential units and first floor retail space. The Palatine in Courthouse is officially completed. This is a 274 unit residential building (behind the Arlington jail) that started as condos but then switched to apartments when the market turned soft. Turnberry Tower, the lavish and expensive condominium building in Rosslyn, is projected to be completed sometime this summer. The views of DC are stunning and the elevators open into your apartment. There is a 5 bedroom unit available with over 5,000 square feet for the low asking price of \$7.12 million. Condo fees are a mere \$2,100/month. I am sure, however, it is fabulous! Troester moved in on 25<sup>th</sup> Street she started wondering the same thing about the eyesore in front of her house – and took action. Ms. Troester discovered that the county builds these objects and then abandons them to the kindness of neighbors.

So, Ms. Troester proposes a "deal." The county has agreed to remove the ugly, overgrown, mishapen juniper currently occupying the site. Ms. Troester is gathering funds from neighbors to fund a planting for the area (and gathering promises of sweat equity as well). She requests matching funds from the Woodmont Civic Association. The Executive Committee recommends that this request be granted, not to exceed \$75.00.

#### Is It Your Turn?

The WCA Executive Committee wishes to form a Nominating Committee to recommend a slate of officers and other positions for the election scheduled to take place at the April meeting.

The positions available are President, Vice-President, Secretary and Treasurer, four delegates and alternates to the Arlington County Civic Federation, and representative and alternate to the Neighborhood Advisory Commission. Your current officers are listed in the box on this page. Representatives to the Arlington County Civic Federation are Bob Kenney, Norm Mosher, Sharon Rogers and Lee Rooker. The position of representative and alternate to the Neighborhood Advisory Commission has not been filled for serveral years and represents a substantial time commitment.

What do the officers do? The President generally arranges for the meetings and conducts them, as well as serving as the primary contact for WCA business. In practice

preparing the newsletter (it is distributed by the group home residents as part of their service agreement to the community), but it is possible that this responsibility could be delegated if the President desired (any volunteers?) The Vice President serves as a back-up for the President, and the secretary and treasurer assume the conventional responsibilities.

Delegates to the Arlington County Civic Federation (ACCF) may be as active or passive as they choose. The ACCF meets monthly, September to June. A snapshot of ACCF activities and interests is available at www.civfed.org.
