Dissertation Globalization and the Canadian Provinces: Costs, Benefits, Responses, and

Consequences

Advisor Abstract Professor William Lammers (recently deceased)

Globalization is affecting both political and economic relationships in Canada. This dissertation examines how this economic force affects Canadian Constitutional law, Quebec's aspirations to be an independent state, monetary and fiscal policy within Canada, and immigration and trade policy from the perspective of the provinces. It also examines how provinces attempt to adjust their political relationships to cope with these economic stresses. It concludes that globalization is contributing to a political and economic fragmentation of Canada and gives possible responses that may be used to counter the ill effects of this process while preserving the benefits. Mathematical models, case studies, econometric analysis, and economic and political theory are used to demonstrate these effects.
