CRATING: **Crating will be tight.** Please crate carefully, efficiently, and considerately. No chairs in the crating area, please.

JUDGING: Please pick up your armband from stewards at ringside before your class begins. Judges will not wait for any dog holding up a class. The owner/agent of each dog is responsible for the presence of their dog in the judging ring when their entry is called.
