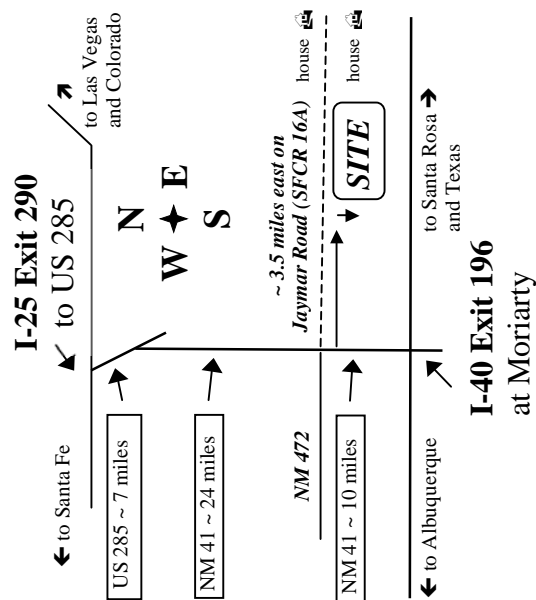

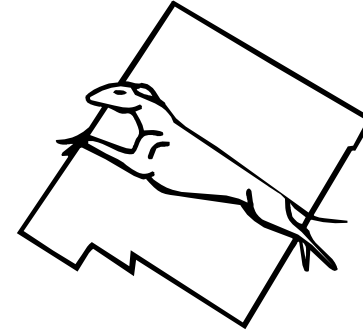
At the intersection of NM 41 and NM 472, turn **EAST** on unpaved Jaymar Road (SFCR 16A) for 3.5 miles.

**TEST/TRIAL HOURS: 8:00 AM until completion.**

**ROLL CALL & INSPECTION (RC&I): Test, 8:40; Trial, 5 minutes after Trial entries close unless completed earlier in the morning.** RC&I for Tests and Trials will be allowed earlier than posted times if inspection team is available – RC&I for Tests will close at 8:45; RC&I for Trials will close 10 minutes after Trial entries close.

**DRAW: begins immediately following Trial Roll Call and Inspection closing times.**

**ELIGIBLE BREEDS AND REGISTRY**--Only purebred Afghan Hounds, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughi, and Whippets that are one year of age or older and have been registered with the American Kennel Club or an AKC recognized foreign registry or that have been granted an Indefinite Listing Privilege (ILP) may be entered. Effective January 1, 2008: Azawakh, Portuguese Podengo, and Thai Ridgeback 1 year of age or older, that have been recorded with the Foundation Stock Service (FSS), or that have been granted an Indefinite Listing Privilege (ILP) are eligible to enter Lure Coursing Tests and Trials for Junior, Senior, and Master Courser titles but are not eligible for championship points.

**Green qualifying ribbons will be awarded to qualifying hounds for Junior Courser Test.**

## TEST OFFERED:

**JUNIOR COURSER:** Open to all hounds of an eligible breed. A hound running alone shall receive a certification from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

*It is recommended that Junior Courser hounds entering the open stake for the first time have successful coursing practice with other hounds before competing.*

## STAKES OFFERED:

**OPEN:** Open to all hounds of an eligible breed that have obtained an AKC Junior Courser title. Hounds that are disqualified from AKC Field Trials may not be entered. Championship points are awarded from this stake.

**SPECIAL:** Open to all hounds that have earned their AKC Field Championship title. Hounds that are disqualified from AKC Field Trials may not be entered. LCX points are awarded from this stake.

**OPEN VETERAN:** Open to all hounds which are eligible to enter Open or Special Stakes and have reached veteran age on the day of the trial (5 years for IW's, 6 years of all other breeds). Championship or LCX points will be awarded.

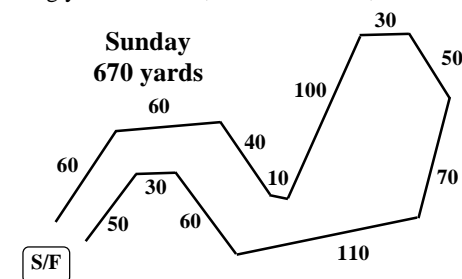
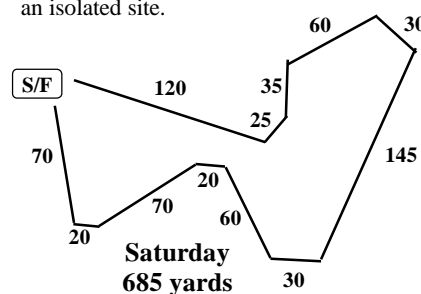
## **BEST IN FIELD WILL BE OFFERED BOTH DAYS**

*Note: Azawakhs, Italian Greyhounds, Portuguese Podengos, Sloughi, and Thai Ridgebacks are not eligible to compete for Best in Field.*

All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a 5-minute grace period. Each entry will be examined at inspection for breed disqualifications. Spayed and neutered hounds, without breed disqualifications, may be entered. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The members of the Albuquerque Whippet Fanciers Association reserve the right to alter the course plan as required by weather and/or field conditions on the day of the event.

**A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.**

The AWFA and Stitt Ranch property owners assume no liability for injury to any person or dog before, during or after these Tests/Trials. Please bring your own food, shade and water, as this is an isolated site.
