



ELIGIBLE BREEDS AND REGISTRIES: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, and Whippets may be entered in the regular stakes. Limited and Provisional Stake breeds currently include purebred Chart Polski, Cirneco dell'Etna, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, and Portuguese Podengo (all three varieties).

All entries shall be individually registered with the American Kennel Club, The National Greyhound Association, The United Kennel Club, the Federation Cynoliguque Internationale, an ASFA-recognized foreign or ASFA board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of the Desert-Bred Salukis (SPDBS). Limited and/or Provisional stake breeds shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

#### **UPON REQUEST, ENTRIES WILL BE ACKNOWLEDGED BY EMAIL**

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call. The Stitt Ranch property owners, ESCA, or its members are not responsible for any accidents at these trials.

#### STAKES OFFERED:

OPEN STAKE - any eligible hound excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE - any ASFA Field Champion.

<u>VETERANS STAKE</u> - Any eligible hound whose age is at least six years, except for Irish Wolfhounds whose age shall be at least five years; and Rhodesian Ridgebacks and Whippets, whose age shall be at least seven years.

<u>LIMITED STAKE</u> - any eligible sighthound of a Limited stake breed that has met certification requirements

<u>SINGLES STAKE</u> - Any eligible sighthound including those disqualified to run in other stakes.


#### **CONDITIONS OF ENTRY:**


- ⇒ The entry for each hound entering the Open, Veteran or Limited Stake for the first time MUST include a completed & signed ASFA Certification Form or Waiver Form. (with proof of title) and a copy of the hound's registration certificate (registration requirement waived for NGA Greyhounds only, certification waived for Single Stake entries only. All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public draw if the entry in any regular stake is 20 or more.
- ⇒ Bitches in season, lame hounds and hounds with breed disqualifications and will be excused at roll call.
- Spayed, neutered, monochid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- ⇒ All hounds will run twice, in trios if possible or braces (Except in Single Stake), unless excused, dismissed or disqualified.

### OTHER:

- ⇒ There will be a \$5 fine assessed for any hound loose on the field, other than those running the course in progress.
- There will be a \$25 fee for returned checks.
- ⇒ Everyone must clean up after themselves and their dogs.

Continuous loop equipment will be used. Back-up equipment will be available. Lure will consist of highly visible white and/or black plastic strips. Course plans (reversed for finals) are shown below. E.S.C.A. reserves the right to alter the course plans, as required, by weather and/or field conditions on the day of the trial. The altitude is 5,600'. Please bring your own shade and water. Overnight self-contained camping is allowed by the field.
