

Blue Ridge Agility Club Application

Blue Ridge Agility is a non-profit club whose aim is to spread the sport of dog agility by holding demos, clinics, matches, and agility trials open to both pure bred and mixed breed dogs. Meetings are held monthly, or as needed, and a newsletter is published as needed.

Annual membership is \$16 individual, \$24 household, \$6 junior (under 18 years). The membership year runs from January 1 through December 31, and Club dues for each year are due and payable on Jan 1st. *New membership applications received from July 1 – Nov 30 pay pro-rated dues of \$8 individual, \$12 household, \$3 junior (under 18 years).* Those joining after Nov 30 will pay the full year's dues which will cover the following year. Make check payable to Blue Ridge Agility, fill out the application, and **sign the waiver (on other side).**

Without limiting the generality of the foregoing hold harmless provisions, I hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by the law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in any events or meetings, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence o the aforementioned parties or any of their members or agents or any other persons."
