Jump Height Order

Championship Program: Friday – varied; Saturday - low to high; Sunday - high to low;
Performance Program: Friday – varied; Saturday - high to low; Sunday - low to high

*Note: Performance program will precede championship for each class on Saturday and follow championship on Sunday.
Masters/P3 Snooker jump height order will be random.*

Required Check-in and Measuring

Check-in is required, but if you include a copy of your permanent card with your entry, you do not need to present the card during check-in. Otherwise, you must present your permanent card, temporary card, USDAA-issued check-in letter or subscriber printout. All dogs MUST be measured UNLESS the dog is jumping 26" (22" Perf), the handler sent a copy of the permanent card with entry or presents the permanent card, temporary card with 3 signatures awaiting a CMJ, or a check-in letter provided by the USDAA / print out of dog info page from subscriber account indicating the dog is permanently carded! Please note: **measurement will only take place between 7:00 a.m. and 7:40 a.m. on each day of the trial. IF your dog needs to be measured, you must do so and check in during the prescribed time on your first day of competition.**

The handler of a dog entered in Team/PVP that measures up MUST notify the secretary at check-in. Should the change in jump height make the dog ineligible for the team, the secretary will make every effort to form complete teams from the available dogs. The dog measured up must jump the higher height for the team/pair to qualify. If the dog runs FEO at the lower height, the team/pair may not qualify, but the partners may earn placements, top ten points and Lifetime Achievement Qs in individual classes. Dogs running FEO are ineligible for prizes/awards and may not be moved to Performance at check-in.

DIRECTIONS TO TEST SITE

From I-40 East or West, the Asheville area, or points north: Take I-26 East to exit 40 (old exit 9); go right (west) for approximately .6 miles. Go past Fanning Bridge Road and turn left into the arena parking lot—usually Gate 4 or 5 will be open.
From the south: Take I-26 West to exit 40; go left (west) for approximately .7 miles and follow directions above.

Dogs must be registered with USDAA in order to compete in USDAA sanctioned events. A registration card and number with a "U" prefix will be issued to facilitate entry at USDAA events and tracking of show results in the regular classes.

Junior handlers (those 18 years of age and younger) and their dogs must be separately registered for participation in the USDAA's Junior Handler Program (UJHP). A registration number with a "J" prefix will be assigned for use in entering UJHP events. A dog competing in both programs (regular classes and UJHP) must be registered separately for each program, for which the total fee is \$37.00.

CLASS DESCRIPTIONS & ELIGIBILITY

The following titling classes are being offered at the Starters, PI, Advanced, PII, Masters, and PIII levels at this event:

Standard, Gamblers, Jumpers, Pairs Relay, and Snooker

A complete description of these classes and the requirements for eligibility for entry may be found in Chapters 3-7 of Official USDAA Rules & Regulations, which are incorporated in this test schedule by reference. A summary of eligibility requirements for all titling classes is presented in Appendix E of the Rules & Regulations. Competitors may enter both Championship and Performance classes for which they may be eligible; however, no dog may be entered in the same class regardless of level at this event (e.g., you could enter Masters Pairs and PIII Snooker, but you could not enter both PIII and Masters Pairs or Snooker). **Relay:** In the event only one dog is entered in a program/level, un-entered dogs or dogs from another program/level may not be recruited to form a qualifying pair. Relay is required for all levels of Performance.

A copy of USDAA Rules & Regulations may be found on the USDAA website at www.usdaa.com. Please note that if you have purchased access to the Subscriber Services area on the USDAA website, you may print a complete copy of the regulations as included in the Subscriber Services Forms & Documents Library at no charge.

The following Tournament classes are being offered at this event: (all competitors are eligible for entry to any of these tournament classes.) A copy of the tournament regulations for each tournament may be found on the USDAA website at www.usdaa.com or by contacting USDAA at P. O. Box 850955, Richardson, TX 75085. (972) 487-2200.

Dog Agility Masters® Team and Performance Versatility PairsSM - A team (3 dogs and 3 handlers) may be comprised of dogs from any two Championship jump heights. A pair (2 dogs and 2 handlers) may be comprised of dogs from any Performance heights. Dogs and handlers compete in five classes; gamblers, jumpers, snooker, standard and relay. After all five classes, the minimum qualifying score will be calculated. One qualifying score as described in the complete rules is required for entry in the World Championships.

Grand Prix of Dog Agility® and Performance National StandardSM - A qualifying score is ZERO (0) faults. One Q is required for entry in a Regional Championships. Two qualifying scores are required for entry in the quarterfinals at the World Championships.

Dog Agility Steeplechase®, and Performance Speed JumpingSM - Two-round tournaments with dogs advancing to Round 2 based upon their scores in Round 1 – a qualifying score is earned in Round 1. **Steeplechase:** One qualifying score as described in the complete rules is required for entry in a Regional Championships, and two are required for entry in the quarterfinals at the World Championships. **Speed Jumping:** Two qualifying scores as described in the complete rules are required for entry in the semifinals at the World Championships.

AWARDS

Titling Classes - Rosettes for 1st through 4th place will be awarded in each jump height (and for mini and open in pairs). Maroon qualifying ribbons will be awarded to all dogs earning a qualifying score in any non-tournament classes.

Dog Agility Masters® Team Tournament and Performance Versatility PairsSM - Prizes and awards will be made based upon overall team scores after the five rounds. USDAA will provide “Gold”, “Silver” & “Bronze” medallions at local qualifying events for the three top scoring teams/pairs. Qualifying pins will be awarded to each member of each qualifying team or pair.

Grand Prix of Dog Agility® and Performance National StandardSM - The first place qualifying handler/dog team in each height class shall earn a “bye” voucher, permitting them to directly advance to the final round of a regional championship. A double maroon and white ribbon shall be awarded to all qualifiers in the Grand Prix, with a double maroon and pink ribbon awarded to all qualifiers in the Perf National Standard. Rosettes for 1st – 4th place will be awarded for each jump height.

Dog Agility Steeplechase® - Prize money shall be computed based upon 30% of the total entry fees to be allocated in accordance with the payout table below regardless of the size of entry in any height class.

Consideration for a position on the U.S. team is offered first to the handler/dog with the highest number of Team Selection (TS) points earned from the first four events attended plus the *Cynosport* World Games.

Points are awarded equally at each event by jump height based upon placements in the Grand Prix, Steeplechase and team individual classes of Gamblers, Jumpers, Snooker and Standard.

Complete rules for selection and details of how points are awarded can be found at www.usdaa.com. Team members are selected by the USDAA Regulations & Competition Standards (RCS) Board to represent the United States in the International Federation of Cynological Sports (IFCS) World Agility Championships to be held in 2010. Four teams of 3 dogs are chosen to compete in the four IFCS height divisions.

NOTICE TO COMPETITORS

Competitors through submission of an entry, acknowledge that they are knowledgeable of USDAA rules & regulations, including but not limited to the following rules regarding entry:

This test is open to all registered dogs being at least eighteen (18) months of age, including purebred and non-purebred, except bitches in season, dogs suffering from any deformity, injury or illness that may affect the dog's physical or mental performance, or dogs exhibiting signs of aggression towards people or other dogs.

All dogs must be registered with USDAA in order to compete in sanctioned events. Registration may be made concurrently with entry by including the dog registration application with your entry. To receive a registration number immediately and a measurement card prior to the show, go to www.usdaa.com, click on General Information, and click on Dog Registration.

No leads, collars, food, toys, or other aids or devices shall be permitted on the course at any time.

Safety shall always be of foremost consideration in actions and conduct by handlers at all times.

The organizing committee may refuse the entry of any competitor or dog for just cause should the committee view that participation by competitor or dog would be prejudicial to the sport. However, any committee so doing must notify the competitor in writing (with a copy to the USDAA office) in anticipation of or upon receipt of entry. The notice must include the reason for refusing the entry and a brief explanation of the basis for their decision. The burden of responsibility for appropriateness of such action rests solely with the host group and its organizing committee.

There shall be no refunds for entries withdrawn after the original closing date, or in the event that a dog is absent, disqualified, excused by veterinarian or judges, or barred from competition by action of the Event Committee. In addition, no entry fees will be refunded if the test cannot open or be completed by reason of riots, civil disturbances, fire, an act of god, public emergency, act of a public enemy, strike, or any other cause beyond the control of the club. Exception: bitches in heat, ill or injured dogs may be withdrawn and the entry fee (less our direct costs) returned upon request of the competitor prior to the opening of the trial. **Request must be accompanied by a veterinarian's statement.**

Refunds of overpayments \$5 or less will not be made.

Returned checks do not constitute a valid entry fee. There will be a \$25 service charge for returned checks. Amounts shall be paid within 30 days of postmarked notice of returned check if such date follows the event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse.

This event will be held in a covered outdoor arena on packed dirt. There is ample room for parking and crating.

A single practice jump will be provided for competitors.

All dogs must be held on leash except when being judged or in the warm up area.

It is expressly understood that competitors alone are responsible for the behavior of their dogs and/or children. A competitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Organizing Committee, be asked to leave the test site.

Fault limits may be set at the discretion of the organizing committee and judge.

A concession stand will be available for breakfast, snacks and lunch.

Please clean up after your dog at the trial site and at your motel.

Practice good pet ownership basics at your motel: never leave dogs unattended in rooms; clean up after dogs immediately; bring a sheet to cover furniture to minimize the effect of dog hair; be courteous to motel staff – motels that allow pets are a privilege. Failure to comply with these basics may result in disciplinary action by the Organizing Committee.

Express mail entries must include a signature waiver.

If a dog must jump a higher height as determined by the judge's measurement at this event, the dog will be moved to the new jump height OR the handler may opt to run For Exhibition Only at the lower height, but no awards or qualifying scores may be earned and no change in program is allowed at check-in.

All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast and telecast rights for this event are the exclusive property of United States Dog Agility Association, Inc.

Portions of this event may be taped for television. Through entry at this event, ALL COMPETITORS and HANDLERS HEREBY GRANT to USDAA and its representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog's name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cablecast, transmission or distribution in any format or media now known. All competitors and handlers hereby release USDAA and its representatives, agents and assigns from any claim or cause of action for invasion of the rights of privacy, right of publicity, right of personality, or any similar right.

- (a) Toy: 30 cm (11.81 in) and under jumps 30 cm
- (b) Mini: 40 cm (15.75 in) and under jumps 40 cm
- (c) Midi: 50 cm (19.69 in) and under jumps 55 cm
- (d) Maxi: over 50 cm jumps 65 cm
