BUSINESS ARISING FROM MINUTES:

Rob Watson was contacted and dates were proposed for training days. Vern and Averill spoke to Lindsay Granger MQ General Manager about this and he advised that Honda RCA has no rider insurance only public liability. If the HRCA decided to hold a ride day at the track it was decided that the Club would ask for participants to buy a Recreational Licence costing \$15 and also charge a per rider fee for the hire of the track. This would then cover the rider for liability insurance.

With all but one bill in for the maintenance on the track, the cost is going to be in the vicinity of \$1500 – expected cost \$2000 a saving of approx \$500.

RACE REPORTS:

There was a slight problem with riders crossing the track at the finish of a race but it was decided to put a STOP sign on the inside of the track to help riders think of the danger.

GENERAL BUSINESS:

The Brisbane City Council will not allow the Club to sink a bore on the property due to health risks. Vern has investigated putting a 30,000 litre tank on the property with a sprinkler system. Lance Winley and Sean Allanson are chasing up prices for the tank. Bushman Tank's price is \$3050 delivered to Brisbane with a 25 year guarantee.

Ray Clacher has a contact that may be able to help with sandy loam for the track and surrounds.

We have been offered a water tank trailer from Robin Ricketts. This is a tow behind trailer of approx. 2,000 litres and the cost is around \$50. David Muirhead and Mike Norgrove are investigating.
