1. ANNOUNCEMENT:

The **BRISBANE MOTORCYCLE CLUB INC**, hereafter called the PROMOTING CLUB will conduct Closed to Club Day **SCRAMBLE** for Seniors at the Raubers Rd Scramble Track, Northgate as per Permit No. MQ.

JURISDICTION

- 2.1. The abovementioned meeting has been authorised by MQ who has issued the Motorcycling Australia Permit Number (TBA) and is open to holders of current Motorcycling Australia National, Club and One Meeting Licences, who are full financial members of the Promoting Club (no discount or one day memberships are allowed).
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR), these Supplementary Regulations, and any Final Instructions approved by MQ.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES:

- 3.1. Entries open forthwith AND WILL BE ACCEPTED BY THE Race Secretary at the above address up to one week prior to the event. Late entries or entering on the day will incur a \$10 extra fee.
- 3.2. In the case of postponement or abandonment of the meeting, all entry fees will be refunded.
- 3.3. Only entries received on the official Entry Form that are accompanied by the correct fee will be accepted.

4. INSURANCE:

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.
- **4.3.** IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.

5. MEDICAL SERVICES:

Queensland Ambulance Service will be available from start of practice until end of racing on the day.

9 AWARDS AND PRIZEMONEY:

All points go to the Club Championships, no prize money is paid.

10 ENTRIES TO CONSTITUTE A CLASS:

- 10.1. The maximum numbers of riders in any Evolution class will be 25.
- 10.2. Should there be insufficient entries in any Class of Competition, the decision to run or cancel the Class, or to combine events and redistribute any awards, will be at the discretion of the club, subject to MQ approval.
- 10.3 In light of Clause 10.2, with an interest to streamline proceedings the practice of sharing machinery is to be discouraged.

11 MACHINES AND RIDERS:

- 11.1. All machines entered must comply with the current GCR's for *Classic Motocross* Competition.
- 11.2. Multiple entry of the one Machine in the same Class of Competition is not permitted.
- 11.3. Change of rider and machine may be permitted if submitted in writing to the Clerk of the Course and with the approval of the MA Steward at least 20 minutes prior to the start of the event in which the substitution is requested. Substitute machine must have been passed at machine examination. Failure of riders to follow this procedure may result in placings not being recorded.

12 RIDING NUMBERS:

- 12.1. Wherever possible, competitors will be allocated heir Registered Riding Number. All others will be allocated numbers at the Club's discretion.
- 12.2. All Number Plates on all Machines MUST comply with the GCR's.

13 RIDERS BRIEFING:

A Riders Briefing will be held prior to the commencement of racing and ALL Competitors MUST attend the Riders Briefing.

14 DRUG AND OR ALCOHOL TESTING:

- All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.
- 14.2 If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the payment of prize money may be delayed at MQ discretion until the results of the tests are known.

15 CODE OF CONDUCT:

All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated in the GCRs) which is a guide to appropriate behaviour atall Motorcycle Race Meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

HEREBY AGREE with the persons, organisations and bodies corporate whose names appear in Schedule 1 (hereinafter collectively called "the organisers") that I am by this agreement entitled to participate in the motorcycle meeting listed in Schedule 2 (hereinafter called "the meeting") at the venue listed in Schedule 3 (hereinafter called "the venue") on the terms and conditions set out in this document.

ACKNOWLEDGMENT OF RISKS, DANGERS AND OBLIGATIONS

- 2. I ACKNOWLEDGE that the sport of motorcycle racing is dangerous and that by engaging in the sport and participating in the race meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- a) that I may be injured, physically or mentally, and may be killed;
- b) that my machinery or equipment may be damaged, lost or destroyed;
- c) that other competitors may ride dangerously or with lack of skill;
- d) that track or event conditions may be hazardous and may vary without warning or predictability;
 - e) that the organisers, officials, landowners/track operators and any agent or representatives of hose in charge of race meetings are frequently obliged to make decisions under pressure of time and/or events;
- f) that any policy of insurance of or in respect of my life or physical or mental health may be avoided;
- g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- h) that I have an obligation to myself and others to compete safely and within the rules of competition.

INDEMNITY GIVEN TO ORGANISERS

- 3. IN CONSIDERATION of the acceptance of me as an entrant in the meeting I AGREE TO INDEMNIFY the organisers and each of them in the following manner:
- a) that I participate in the race meeting at my sole risk and responsibly;
- b) that I accept the venue as it stands with all or any defect hidden or exposed;
- that I indemnify and hold harmless the organisers, their respective servants, agents or officials against any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or rising out of my death or any injury, loss or damage caused to me or to my machine or equipment whether caused by negligence, breach of contract or in any manner whatsoever.
