Here is a list of some of the changes this year that you will need to know about prior to the start of the 2007 tournament and league play.

- 1. Tournament averages will be figured by adding the league actual scores and game to the tournament actual scores and games and divided by the total number of games pitched.
- 2. The Tournament of Champions will be a two (2) day event now. There will be a junior division and a team challenge played on Saturday, October 20th.

There were a few other changes that will be discussed at the Spring Meeting, so if you can make it, please be there..., again, it is VERY important that the club Secretaries and Presidents be there.

- 3. Each Membership Card must be signed by a league secretary and be presented at each tournament.
- 4. Check the State Entry Form for prices. ALL ENTRIES MUST BE SUBMITTED TO RAMONA BUSTER BY SEPTEMBER 1, 2007.
- 5. Every entrant will receive a confirmation of his or her pitching times, prior to the tournament.
- 6. All contestants will pitch 5 games.
- 7. All awards will be given out at Rally Day.
- 8. All contestants will pay the scorekeeper \$0.50 per game.

LEAGUE NEWS

Juniors will now pitch with the adults, due to lack of junior pitchers.

The Board voted to take the "750 shoes" out of the rules for pitching in the State and recommended that if you do not have an established handicap, you must pitch in two tournaments prior to the State to establish your handicap.

The rule allowing a pitcher to pitch two times (if desired) in a tournament was voted in as permanent rule.

If a pitcher changes distance a new handicap must be established. A vote was taken in favor of the motion.

Instead of classes, it was voted on to pay the top 50% of pitchers. Their scores plus handicap will determine the top 50%. This was for a period of one year.

The **Tournament Of Champions** is back by popular request!! Additional information will be given out in the near future. Be sure to contact your league secretary for more information. There will be some minor changes, along with a youth and team division.
