Important: NAC Entry deadlines are listed for each tournament. **MAIL EARLY. Postmarks are not considered** - entry (fees and form) must arrive at the USFA National Office by the deadline, or they will be charged a late fee of **triple the total fee**: registration fee plus event fee(s). Late entries will be accepted up to one week prior to the first day of the tournament. For refund of event fee(s), withdrawals must be reported in writing to the National Office by the Monday before the first day of the tournament. **Registration fees are nonrefundable**.

Method of Payment for NAC Entry Fees: Make check or money order payable to the US Fencing Association. The entry form and payment must be mailed to: USFA ENTRIES, One Olympic Plaza, Colorado Springs, CO 80909-5774. If paying by credit card (see front of form), entry may be sent by fax to (719) 632-5737. Entry form and fees must be received by the stated deadline to be accepted. If multiple copies of an entry are received, each copy will be charged unless noted as Duplicate.

Entry Receipt: You must include a self-addressed stamped postcard, or a fax return sheet with your entry for confirmation of receipt of your entry. This will be the only acceptable proof of submission of entry.

Eligibility: Every person competing in the North American Cup must be a current competitive USFA member, expiration date of July 31, 2001 or later, or show a 2000-2001 FIE license.

Athlete can fence in an age category IF: 1) the athlete's birth year falls in that age bracket OR 2) the athlete is on the national point standings in the next younger age bracket. For example, if a fencer was born in 1990, the fencer is eligible for Youth 10 and Youth 12 but inYouth 14 ONLY IF fencer is listed on the current Youth 12 point standings. For that same fencer to be eligible to fence in a Cadet event, the fencer must have earned points at a Youth 14 competition and be listed on the current Youth 14 point standings.
