The system facilitates better communication the with federal project director, so information is forwarded from Project YELL. as well as reports and other information may be received.

- Social Norms Conference Carol, April, Deb and Lorraine will attend the Social Norms conference next week. Each will attend a different workshop/break out group.
- **Project YELL Steering Committee** is this Substance Abuse Committee.

- Peer Leaders Last year's students were laid off when the grant was de-funded. They will be re-interviewed to access interest. Students who are able to go into the community and use public speaking skills are needed.
- Youth Summit At a recent Youth Summit, high school attendees participated in asset mapping, made an action plan, and prioritization of gaps in service. The interactive conference was all about environmental strategies. The yearly event costs \$100 person. Workshops per included compliance checks, Youth In Action roll call briefings, media advocacy and shoulder taps.
