**1. Can I pick my own number or personalize my tag?**

*No, neither of these options is available as sequential numbers will be assigned by the state.*

**2. Are these tags available for other types of vehicles (Boats, Motorcycles, ATV)?**

*No, not at this time*

**3. Are handicap tags available?**

*No*

**4. Do any of the proceeds go to LSU?**

*No, all proceeds will be distributed into the state's General Fund.*

**5. How will I know it is time for me to pick up my tag?**

*You will be contacted by a member of the Tag Committee. At that time, you will go to your local tax collector's office.*

**6. How soon should I pick up my tag?**

*Please pick up your tag as soon as you are notified by the tag committee. If you choose to wait until the expiration date of the tag already on your vehicle, the special tag fee (\$51.00) shall be paid again.*

**PLEASE NOTE:**

200 TAGS MUST BE PRESOLD BEFORE THE MISSISSIPPI STATE TAX COMMISSION WILL BEGIN PRODUCTION ON A PARTICULAR DISTINCTIVE TAG INCLUDED IN HOUSE BILL 468. WHEN THE TAX COMMISSION RECEIVES THE 200 APPLICATIONS, WITH THE APPROPRIATE FEES, AND A DESIGN PROVIDED BY THE ORGANIZATION AND APPROVED BY THE TAX COMMISSION, THE TAG CAN BE PUT INTO PRODUCTION.

THE APPLICANT WILL BE NOTIFIED BY THE ORGANIZATION RESPONSIBLE FOR THIS PARTICULAR TAG WHEN HIS TAG CAN BE PICKED UP AT THE OFFICE OF THE TAX COLLECTOR IN HIS COUNTY OF RESIDENCE. THE TAX COLLECTOR'S OFFICES WILL HAVE A LIST PROVIDED BY THE TAX COMMISSION OF PEOPLE WHO HAVE ALREADY PAID THEIR FEES AND ARE ENTITLED TO ONE OF THE FIRST 200 TAGS.

**THE APPLICANT SHOULD PICK UP HIS TAG AS SOON AS HE IS NOTIFIED THAT THE TAG IS AVAILABLE AT THE TAX COLLECTOR'S OFFICE. IF THE APPLICANT CHOOSES TO WAIT TO PICK UP HIS TAG UNTIL THE EXPIRATION DATE OF THE TAG ALREADY ON HIS VEHICLE, THE SPECIAL TAG FEE SHALL BE PAID AGAIN.**
