**Obedience Classes: Novice, Open, Utility, PreNovice, Grad. Novice, Brace**  
Fees: First obedience entry \$8, additional entry same dog \$6.  
First rally entry \$8, additional entry same dog \$6.  
Pre-entries must be received by Monday, May 15th; No refunds after that date. Day of match entries: 9:30–10:45am. Judging starts: 11:00am.

### AKC CGC Test, 10 AM–12 Noon

Pre-entries must be received by May 15, 2006. Day of test entries accepted until 11:45am if space is available. Open to dogs of all breeds— “All-Americans” welcome! No food allowed. Buckle or slip collar only. Bring a brush/comb, and a copy of dog's current rabies certificate & town license. CGC Fee \$15.

Shade, water & restrooms available.

Bring chairs & lunch; snacks/drinks available for purchase.

**Directions** *From the west:* via Mass. Pike, take exit 14 and follow signs to Route 128 (I-95) and Route 30. Take exit to route 30 East (towards Newton). Go one mile east on Route 30. Turn left at lights (Lexington Street) and bear left at the fork onto Freeman Street. Turn left onto West Pine Street and follow to end.

*From the east:* Take Commonwealth Ave (Route 30) to Lexington Street. Turn right at the lights, and then bear left at the fork onto Freeman Street. Turn left onto West Pine Street and follow to end.
