Not For Profit Toolkit

Julie Wood reported on the presentation sponsored by Hospice Dufferin of this web-based software for volunteer management. The hope is that this would become a "virtual" Volunteer Centre. The project requires an initial license of \$2500 which The Volunteer Centre hopes to cover by obtaining a Trillium Grant. Annual fees would be approximately \$1.25 per volunteer per agency with a minimum charge of \$100. Helen Sherrard will contact Maureen at Hospice to clarify details.
