 - ii) Std 563 ***“IEEE Guide on Conductor Self Damping Measurements”*** was reaffirmed by ballot in June 2002. The ballot invitation is open until July 8, 2007. Contact: Patrick Clark
 - iii) Std 664 ***“IEEE Guide for Laboratory Measurement of the Power Dissipation Characteristics of Aeolian Vibration Dampers for Single Conductors”***. The standard was reaffirmed in March 2000. Recirculation ballot completed in 2007. Submittal to RevCom for Sept meeting underway. Contact: Patrick Clark
