For the purpose of authorizing Prince George's County, Maryland, to borrow money upon its full faith and credit at any time and from time to time, in an aggregate principal amount not exceeding \$55,900,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation, or repair of Public Works and Transportation Facilities, including the acquisition of sites therefor; prescribing terms and conditions upon which bonds issued pursuant to this Act shall be issued and sold and other incidental details with respect thereto; providing generally for the issuance of such bonds and providing for such borrowing to be submitted to a referendum of the legal voters of the County.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Prince George's County, Maryland (the "County"), is hereby authorized, pursuant to Section 323 of the Charter of Prince George's County, Maryland (the "Charter"), to borrow money and incur indebtedness upon its full faith and credit, at any time and from time to time, in an aggregate principal amount not exceeding \$55,900,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation, or repair of, Public Works and Transportation Facilities (including roads and bridges, parking lots and maintenance facilities), including the acquisition and development of sites therefor, the architectural and engineering services incident thereto, and the acquisition and installation of necessary fixed permanent equipment therefor; all such capital projects hereby being found to be (and also being in fact) of the same generic class and being described in the capital program of the County for the fiscal years 2005-2010, under the following headings, which descriptions are incorporated by reference as if set forth herein:

CHARTER AMENDMENT

AN ACT concerning
Amendment of Section 307A, Charter of Prince George's County
For the purpose of proposing an amendment to Section 307A of the Charter of Prince George's County concerning the application of term limitations to Council members and eligibility of Council members and providing a precedence clause in the event of conflicting charter amendments ratified by the voters at the November 2004 general election.

BY proposing an amendment to:

Section 307A,
Charter of Prince George's County, Maryland.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the following amendment to Section 307A of the Charter of Prince George's County,

the Charter of Prince George's County concerning the selection of a Chairman and Vice Chairman of the County Council, and further providing that if there are conflicting Charter amendments adopted by the qualified voters of the County at the general election in November, 2004, the amendments proposed in Council Bill-56-2004, as ratified by the voters, shall prevail.

BY proposing an amendment to:

Section 311,

Charter of Prince George's County, Maryland.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the following amendment to Section 311 of the Charter of Prince George's County, Maryland, is hereby proposed:

Section 311. Officers of the Council.

The Council shall elect from among its members a Chairman and a Vice Chairman. The Chairman, or in his absence the Vice Chairman, shall preside at all meetings. On all questions before the Council the Chairman and Vice Chairman shall have and may exercise the vote to which each is entitled as a Council member. If, at the general election in November, 2004, an amendment concerning the at-large election of the Chairman of the Council shall be adopted by a majority of the qualified voters of the County, then notwithstanding such amendment to this Section or Section 307A concerning at-large members of the Council, the current manner of election of the Chairman and the Vice Chairman of the Council shall remain unchanged. If, at the general election held in November, 2004, the qualified voters of the County shall not adopt an amendment to this Charter providing for the at-large election of the Chairman of the Council, then this amendment to the Charter shall be automatically abrogated and of no effect and shall be deleted from the text of the Charter.

SECTION 2. BE IT FURTHER ENACTED that a copy of this Act be transmitted to the County Executive for publication and that a copy also be transmitted to the Board of Supervisors of Elections for submission of the proposed amendment to the voters of this County at the 2004 General Election pursuant to Section 1105 of the Charter.

SECTION 3. BE IT FURTHER ENACTED that the question of adoption of this proposed Charter Amendment shall be submitted to the voters of the County at the General Election occurring on November 2, 2004, and shall be placed on the ballot in the following form:

PROPOSED CHARTER AMENDMENT

To reaffirm the manner of election of the Chairman and Vice Chairman of the Council, and provide a precedence clause in the event of conflicting charter amendments ratified by the voters at the November 2004 general election.

SECTION 4. BE IT FURTHER ENACTED that in the event that no petition for Charter Amendment or for referendum hereafter meets all requirements of law and, therefore, is not placed on the November 2004 ballot, then this Charter Amendment shall not appear on the local ballot.

**A PETITION TO AMEND THE CHARTER OF PRINCE
GEORGE'S COUNTY**

PROPOSED CHARTER AMENDMENT

To enlarge the Council from nine to eleven members, adding two at-large members; providing that term limits on district members do not apply to a district member running for an at-large seat on the Council; providing that the at-large member receiving the greatest number of votes shall be Chairman of the Council.

Section 301,

Charter of Prince George's County, Maryland.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the following amendment to Section 301, Charter of Prince George's County, Maryland, is hereby proposed:

Section 301. Composition.

The Legislative Branch of the County government shall consist of the County Council, hereinafter referred to as the Council, and the officers and employees thereof. The Council shall be composed of nine members. In the event that a Charter amendment adding two at-large Council member positions is ratified by a majority of the qualified voters of the County at the general election held in November 2004, then no at-large Council member may be a voting member of the Council. If, at the general election scheduled for November 2004, the qualified voters of the County shall not ratify an amendment to this Charter adding two at-large Council member positions, then this amendment shall be automatically abrogated and of no effect and shall be deleted from the text of the Charter.

SECTION 2. BE IT FURTHER ENACTED that a copy of this Act be transmitted to the County Executive for publication and that a copy also be transmitted to the Board of Supervisors of Elections for submission of the proposed amendment to the voters of this County at the 2004 General Election pursuant to Section 1105 of the Charter.

SECTION 3. BE IT FURTHER ENACTED that the question of adoption of this proposed Charter Amendment shall be submitted to the voters of the County at the General Election occurring on November 2, 2004, and shall be placed on the ballot in the following form:

PROPOSED CHARTER AMENDMENT

To establish voting rights of at-large Council members and to provide a precedence clause in the event of conflicting Charter amendments ratified by the voters at the November 2004 general election.

SECTION 4. BE IT FURTHER ENACTED that in the event that no petition for Charter Amendment or for referendum hereafter meets all requirements of law and, therefore, is not placed on the November 2004 ballot, then this Charter Amendment shall not appear on the local ballot.

Adopted this 30th day of July, 2004, by an affirmative vote of two-thirds of the members of the full County Council.
