.... With Liberty and Justice for All....

The Constitution of the United States of America is based on the premise that Aall men are created equal@ and should be given equal rights in the pursuit of happiness. Despite this very basic tenet of truth and foundation for this Country, we have a history over disputes for equal rights. The Black, the Indian, the Oriental, other foreigners, women, and now homosexuals. The cry of each has been the same -Equal opportunity in employment, education, religion (personal beliefs), family, economic growth or failure upon their own actions and not of others actions against them. Why is it so hard for the majority to let go of their Apower@over others by truly allowing everyone the same choices and freedoms they have? We have come a long way since the days of Colonial America, or so it would seem. However, our advances seem partial and superficial at best when it becomes apparent through our continual struggle with equality - freedom of choice/agency - for all, that we have yet to truly comprehend what it means to give everyone, despite our differences of opinion, the same full rights as any other Aworthy@ male/female/person. It is common knowledge that the boundaries between church and state in this country have become less defined than they may or may not have previously been. Our government has found it increasingly necessary to redefine some of such by regulating some school practices. For example, it is no longer a legal practice to hold a group prayer during graduation. However I feel that real nature of my complaint is of a somewhat more extreme definition regarding the rights which many have taken for granted.

In the past few years, it has been common knowledge that many religious organizations have given money to certain political organizations to push into place laws that further a religious infiltration into our system of law. The most apparent are the Christian Coalition which lost its political seat in government and tax-exempt status almost too late, and now the AMormon@church with its direct contributions to anti-gay marriage laws of \$1.1 million in the states of Hawaii and Alaska and the directive to all its California members to use all of their expendable resources (money and time) to the anti-gay marriage laws presently being under vote.

The particular push now is against gay marriage. There are many sides to this complex issue. It has been argued that gay marriage should be determined by the religion itself as that marriage is a religious ordinance. But do the religions stop to think that to force a person to follow what they believe in is much like unto the evil one that their religion warns against? Would God (whoever/whatever he/she/it may be) force us to one will? Of course not, for we are not, nor should anyone take upon themselves that Aprivilege@of deciding for another what is right. This of course deals with moral issues and still falls right in line with what the Constitution in writing and voice has determined as self-evident inalienable rights.

I feel that it is abominable that any organization would use money, especially untaxed dollars, to buy votes toward their own empowerment over any group of people, and further more sinful to take advantage of their tax-free status by using religious money toward a non-religious and blatantly political end.

For those of you who believe that because you are not gay or lesbian this does not affect you, please reconsider. Although this may be taken as pure speculation by many, it is logic, and has been proven in history time and time again. I believe that we deserve equal treatment. I say that if we cannot have marriage between two people who love one-another, than neither should anyone else. I also believe that our political leaders who have passed along the buck regarding our issues because they have not the strength to stand tall against the tide of religious ideas, and religious zealots with their continuous onslaught of biased opinions, and for their own ambitious reasons, must be made to acknowledge the state of inequality within our deteriorating country and make the necessary changes to once again unify our country. I believe that the power for change should be given back to those with strong minds and hearts, and away from those with strong wallets.

In many aspects our country has once again become segregated. Let us as a people end segregation forever. We are one-people in the end, and if there is anything that is keeping us segregated it is the governments failure to give us equality within the law. Let the law stand separate from religion, and from the power of the dollar to buy an unfair legislature. Let our President and our Congress become once again men and women of character, honesty, and fairness in their dealings. Let our courts once again look toward truth and right in their dealings, and let all the citizens unite together for strength against bigotry, dishonesty, and violence. We all should have better, and can by working together to bring our personal agendas in alignment with our common goals. Move together for a better future, and cause those who would stand against equality to stand down, no matter what their title and position is.
