**Driving directions to Lynda's Home –
1118 E. 33rd Ave** (1/2 way between
Arthur and Perry)

**House Colors – White with Green Trim, big
front porch with American flag and a
Welcome flag out front.**

From the West – By I-90

--Get off at the Division St exit and at
the traffic light turn south (right).

--You will be heading up the hill towards
Sacred Heart Hospital. Follow the street
around the Hospital, continuing south
through 2 traffic lights.

--At the second light follow the main
traffic flow(east then south-east) to go
around the Park Inn, you will be on
Grand Blvd.

--Take Grand south to 33rd Ave. (4
blocks past 29th and Grand, there is the
[brick]Manito Methodist Church on the
NW corner of 33rd and Grand).

--At 33rd turn East (left) and drive 1 ½
blocks, there is a stop sign at Arthur and
we are ½ block more. --We are on the
south (right) side of the street with a BIG
pontoon boat in the driveway.

From the East – By I-90

--Take the Freya-Thor-Ray exit, stay in
the right lane and go through the first
stop sign onto the traffic light, where you
turn south (left).

--Follow Thor/Ray past the Fred Meyers,
on up the hill to 29th Ave.

--Turn west (right) and follow 29th Ave to
Perry

(past the Lincoln Heights
Shopping Center, past
Applebee's on your right, past the
Waterford Retirement Center on
your left to a 3-way Traffic Light
at Perry).

--Turn South (left, the only way you can
turn on Perry there) onto Perry and go 4
blocks to 33rd (between the Fire Station
and the Library).

--Turn west (right) and drive ½ block to
my home on the south (left) side of the
street.

Park anywhere you can on the
street.....and come on in!
