¹ The statute does not define the term "locksmith". Webster's Third New International Dictionary defines a locksmith as follows: "a worker who makes or repairs locks". It is the position of the vendor that the term 'locksmith' may be deemed to include any individual or entity of which a reasonable and substantial portion of whose job description includes activities normally associated with a locksmith as that term is defined, for example, but not by way of limitation: the security or maintenance department of a hospital of a hospital, a tow truck operator and so forth.

² Under federal law, we are required to request your taxpayer identification number. Under federal privacy laws, we do not have the authority to collect it, and as such, you have the right to refuse to provide it without penalty.
