Request: TODAY, DURING "LAUNDRY EXCHANGE" DEPUTY SEAL CARRIED OUT A STRIP SEARCH. I REQUESTED THAT HE MAKE AVAILABLE TO ME THE PRIOR WRITTEN AUTHORIZATION AS REQUIRED UNDER P.C. § 84303(F)(1). DEPUTY SEAL INFORMED ME THAT HE DID NOT REQUIRE PRIOR WRITTEN AUTHORIZATION TO CONDUCT A STRIP SEARCH, AND, HOLDING THE DOOR OF MY CELL HALF CLOSED ORDERED ME TO REMOVE MY COVERING AND STAND NAKED BEFORE HIM. LOOKING OVER MY SHOULDER I SAW DEPUTY SEAL IN THE DOORWAY, AND DEPUTY BURCH (FEMALE GUARD) STANDING THERE AND BEHIND HER A BLONDE-HAIRED FEMALE INMATE ALSO WATCHING. EARLIER DURING THE SEARCH I OBSERVED OTHER INMATES NAKED IN THEIR CELLS WITH THEIR DOOR OPEN. (INMATES JOHN HANCOCK AND INMATE ISRAEL DRAPER). FURTHER WITH INMATES IN THE POD WHO ARE H.I.V. AND HEP C POSITIVE THE DEPUTIES HANDED PERSONAL DRINKING VESSELS WITH THE SAME GLOVES WHILE CHECKING THE PERSONAL DRINKING VESSELS OF THOSE INMATES. SINCE THERE APPEARS TO BE NO PRIOR WRITTEN AUTHORIZATION IT MUST BE ASSUMED THAT THIS SEARCH WAS CARRIED OUT PURELY FOR THE PERSONAL AND SEXUAL GRATIFICATION OF DEPUTIES BURCH AND SEAL, WHICH IS A

FELONY - LEWD AND LASCIVIOUS BEHAVIOR - UNDER THE CALIFORNIA PENAL CODE
