## What's the purpose of this?

To draw attention to the danger to civil liberties posed by the USA Patriot Act (USAPA). The USAPA gives the FBI and CIA unprecedented access to records of private individuals. Your medical and financial records, and even your email may be read without your knowledge.

## How does this relate to the library?

Your library records (and your bookstore purchases) may be requested by federal agents. The federal government can obtain information on your reading habits without notifying you. In fact, the USAPA makes it a felony for a librarian or bookstore owner to notify you that they have complied with such a request.

## Why is LCJD involved?

We believe that a healthy democracy requires the free flow of ideas. If citizens become afraid to read and consider varied perspectives on local, national and world events, then the vitality of our society is at serious risk.

## What's happening today?

We are doing a mass-checkout of certain library books to express our concern.

## How does it work?

We are running an "assembly line" to minimize the impact on library staff and patrons. To participate, please do the following:

- Choose one of the short reading lists on the back of this page, according to your own interests.
- When you reach the front of the line, check out the two or three books on your chosen reading list using the self-service scanner.
- Proceed to the main desk, where a librarian will check the books back in.
- Carry the books back to the front of the line, and give them to the next person waiting for them.
