rBGH UDATE:

To bring you up to date about the hearing Dec. 1 at the Dept. of Ag on labeling of milk and dairy products (the proposed rBGH regulation): Devrin testified against the regulations and presented the petition we had in the store–with over 100 signatures. Several consumers, including Co-op shoppers, were also among the opponents.

Testimony against the new rules was about evenly divided between Kansans and representatives of national organizations such as Sierra Club, Organic Trade Association, Physicians for Social Responsibility, and Consumers Union. Devrin's testimony really made the point in a way that no one else was able to that even if Kansas dairy products could meet the proposed new labeling requirements, what comes in from other states will not! And we Kansans would just be left without these products, or they would have to stop making their non-use of rBGH known on the labels, for everybody. They can't and won't re-label just for Kansas, or any other state with rules that don't match the federal guidelines.

One of the people who had come from the West Coast to testify sent us a summary description of the hearing from his point of view. Here is what he had to say in part:

"I thought the star of the show was Devron [sic] Forte, the manager of the Topeka Natural Food Coop. He had a cooler full of dairy products labeled rBGH-free that he brought up one by one, saying that there was no way all these companies would label just for Kansas and that the rules would be devastating for his dairy section. Then he read a powerful letter from Nancy's Yogurt...describing what a nightmare the production and distribution of her products would be if these rules went through."

Another excerpt from the above summary:

"It was standing room only --more than 50 people. There were 16 people testifying against the rules, 6 for, and one in the middle. A few people also turned in written comments but didn't testify orally."

The hearing officer said that Ag Secretary Adrian Polansky will review all the comments and testimony. There is no deadline for him to act.

He has the option to:

1. Keep the rules as they are (or with inconsequential changes) and enact them.

2. Rescind the rules.

3. Change them in a substantial way. If he chooses to do this, the process would have to start again and there would have to be another hearing.

A Dept. of Ag spokeswoman has suggested it would be very unusual for the rules to be rescinded, having come this far. However, some observers believe the Secretary might wait to see the outcome of a lawsuit in Ohio, challenging a similar rule on grounds of violation of freedom of speech and interfering with inter-state commerce. It was hinted, though not threatened, in testimony that dairy farmers (the majority of whom do **not** use rBGH) might bring suit in Kansas also, if the regulation is approved.

If you have not contacted Governor Sebelius, it may still be worthwhile to write her a note giving your views on the subject.
