Please be advised that the Shrine Auditorium does not allow outside food or beverages, including water, in the ballroom.

**Presentations:**

- Solo Dance performance                      2 ½ minutes
- Formation Team performance                      4 minutes

Newcomer, Bronze, Silver, Gold, and Open.

The dance style should be listed in one of the following categories: American, International, Country Western, or Theater Arts/Cabaret.

**Entry Fees:**

- Solo Dance performance \$20.00 per couple
- Formation Team performance \$10.00 per person
- (all dancers, professional and amateur)
- Ballroom Admission for the entire day
- Members \$10.00
- Nonmembers \$10.00
- Academic Students with ID \$10.00
- Children 12 and under Free

Admission to the ballroom is **not included** in the dance entry fee. Professionals who dance in the Showcase will receive a complimentary admission to the ballroom and Tea Dance.

**All dancers** participating in the Showcase must sign and return the liability release form. **The signed forms must accompany all entry forms.** USA Dance will cover the liability insurance charge for all participants. Please use the Entry Form to calculate fees for all performances. **Strict adherence to registration deadline and registered dances will be observed.** To be considered, time preferences must be listed on the entry forms. Corrections only will be made to the program; no additions or substitutions will be accepted.


