ORDER

Came before the Court to be heard on the seventh day of April, 1999, the appeals by Amber Rowe, by counsel, of the preliminary removal orders entered on February 26, 1999, by the Juvenile and Domestic Relations District Court for Scott County granting temporary legal custody of Ryan Rowe and Jacob Rowe to the Scott County Department of Social Services with the finding by that Court of abuse or neglect of these children.

Present at the hearing by this Court were George C. Maddux, counsel to Amber Rowe; Jeffrey S. Hamilton, guardian ad litem for Ryan Rowe and Jacob Rowe; and counsel to Scott County Department of Social Services, C. Dean Foster, Jr.

The Court heard argument of all counsel on the Motion to Dismiss Appeals previously filed by Scott County Department of Social Services and after consideration thereof the Court does hereby

**ORDER:**

That the appeals of Amber Rowe of the preliminary removal orders entered by the Juvenile and Domestic Relations Court are hereby dismissed as the preliminary removal orders entered by the Juvenile and Domestic Relations Court under Virginia Code Section 16.1-252 are preliminary orders and are not final orders of that Court appealable to the Circuit Court as permitted under Virginia Code Section 16.1-296.

It is further **ORDERED** that these cases are hereby stricken from the docket of this Court and are remanded to the Juvenile and Domestic Relations District Court for Scott County for such further proceedings as may be had by that Court.
