(printed name of Participant) (the minor), a minor, do hereby consent to his/her participation in the Weymouth Junior Basketball League (WJLB) and do forever RELEASE, acquit, discharge, and covenant to hold harmless the town of Weymouth and/or any governmental agency whose property any scheduled activity may be required to use, and all of their officers, members, organizations, agents and employees, the WJBL and all of their officer, members, affiliated organizations, agents, and employees from any and all actions, causes of action, and claims on account of, or in any way growing out of, directly or indirectly, all known and unknown personal injuries or property damage which I may now or hereafter have as the parent or legal guardian of said minor, and also all claims or right of action for damages which said minor has or hereafter may acquire, either before or after he/she has reached his/her majority resulting from his/her participation in the WJBL programs.

I acknowledge that I have voluntarily applied for the minor to participate in the sport of basketball with the WJBL. I understand that the activities of basketball involve risk of harm. I am aware of the risks and dangers inherent with those activities, and I knowingly and willingly assume the risk of injury, including but not limited to injury that might result from running, turning, jumping, loss of control, collisions with other participants, and other obstacles, whether obvious or not obvious.

I understand that accidents or illness can occur while playing basketball. In consideration of and as a part payment for the right to participate in activities organized by WJBL, and any other related activities, I agree and state that the minor is fully capable of participating in those activities, is in excellent health with no known physical handicaps that might hinder his/her full participation in those activities, and he/she is fully capable of handling the hazards of basketball, and all and any similar conditions associated with the activities scheduled by WJBL and related activities.

I further agree not to sue, claim against, attach the property of, or prosecute the WJBL and all of their officers, members, affiliated organizations, agents, and employees or any state or local government agency, and all of their officers, members affiliated organizations, agents, and employees for any injury or death caused by or resulting from the minor's participation in the activities provided by or associated with the WJBL, whether or not such injury or death was caused by or resulting from negligence or any other cause.

This Release shall be legally finding on me, my estate, heirs, assigns, legal guardians, and personal representatives as well as the minor and the minor's estate, heirs, assigns, legal guardians, and personal representatives.
