## **RULES OF CAMBERWELL BATHS CAMPAIGN**

### **Preliminary**

1. The name of the Association shall be The Camberwell Baths Campaign. -
2. The Association shall be a members' Association.
3. The objects of the Association shall be to campaign for the long term future of Camberwell Baths and Leisure Centre on behalf of its existing and potential users, the local community, other local organisations and all those interested in the future of Camberwell Baths and Leisure Centre and such other ancillary purposes as the Founding Members see fit.
4. The first members of the Association shall be those listed at the foot of these rules ("the Founder Members").
5. Additional members of the Association shall be admitted to yearly membership subject to these rules. Membership shall be free, with the option of donation. The Association may from time to time prescribe a maximum number of members.

### **Committee and officers**

6. There shall be a Management Committee of not less than 2 and not more than 10 members of the Association, which shall manage all the affairs of the Association except where these rules provide for decisions to be made by the Association in General Meeting. The quorum for the Management Committee shall be 2.
7. There shall be a Chairman, a Treasurer, a Secretary and a Membership Secretary who shall be *ex officio* members of the Management Committee, together with such other officers as the Association may from time to time resolve.
8. The first Management Committee of the Association shall consist of the Founder Members and the first Chairman, Treasurer and Membership Secretary shall be as the Founder Members resolve. The Management Committee and officers of the Association shall thereafter be elected by the Association in General Meeting. Any vacancy occurring by resignation or otherwise shall be filled by the Management Committee.
9. The officers of the Association shall be entitled to an indemnity out of the assets of the Association against all expenses and liabilities properly incurred by them in the management of the affairs of the Association.

### **Trustees**

10. There shall be no more than four and not less than two trustees of the Association, who shall hold all funds and other property of the Association on trust for the use and benefit of the Association, holding and dealing with the property in accordance with the directions of the Management Committee.
11. The first trustees of the Association shall be the first Chairman and Treasurer. Additional or replacement trustees shall be elected by the Association in General Meeting.

12. The trustees shall be entitled to an indemnity out of the assets of the Association against all expenses and liabilities properly incurred by them in discharge of their duties.

### **Subscriptions**

13. The first year's subscriptions shall be determined by the Founder Members. Otherwise, the level of subscriptions for the year shall be determined by the Association in General Meeting, but may be delegated to the Management Committee. Different subscription levels may be provided for different classes of member.
14. Subscriptions shall be payable within 30 days of the member's receipt of an invitation to subscribe. The Management Committee may suspend until payment the membership of any member whose subscription remains unpaid after those 30 days.
15. The Treasurer shall keep records and accounts sufficient to allow the presentation at the Annual General Meeting of an accurate report and statement upon the Association's finances.

### **General Meetings**

16. An Annual General Meeting of the Association shall be held in April of each year.
17. A General Meeting may be summoned at any time by the Management Committee and shall be summoned by the Management Committee or by written notice subscribed to by members constituting not less than one-third of the total membership.
18. Notice of a General Meeting may be given by sending a notice to members at their last known address at least 14 days before the meeting. Notice of any resolution to be proposed at any General Meeting may be given in the same way at least 3 days before the meeting.
19. The Chairman, or in his absence a member selected by the Committee, shall take the chair. Each member present shall have one vote and resolutions shall be passed by a simple majority. In the event of equality of votes, the Chairman shall have a casting or additional vote.

### **Alteration of rules, dissolution**

20. These rules may be amended, added to or revoked, or a resolution passed to dissolve the Association, by a majority of two-thirds or more of members present and entitled to vote at any General Meeting of the Association provided due notice has been given specifying the resolution proposed.
21. If a resolution is passed to dissolve the Association the Committee shall take immediate steps to realise all assets of the Association and to discharge out of those assets all liabilities of the Association and any balance remaining shall be disposed of as the Association in general meeting shall resolve or, failing a resolution, by equal division amongst those who were ordinary members at the date of the resolution to dissolve.

### **Finance**

22. All money payable to the Association shall be received by the Treasurer and deposited in a bank account in the name of the Association. No sum shall be drawn from that amount except by cheque signed by two of the three signatories who shall be the Chairman, Secretary and Treasurer.
