#### PRESIDENT'S MESSAGE

The past two months have been very busy with our annexation vote, new mayor, taxes etc. As most of you may know, we voted to be and are now part of Belle Isle. Thanks to all, especially to Ralph Winterhoff, for helping make this a reality.

The goals the Board set for itself a year ago were (1) resolving the ongoing annexation issue which began more than three years ago, (2) resolving outstanding ARB issues, and (3) start doing something positive with our Association funds. Today, most of these goals have been attained or plans have been set in action.

Last month we had our annual Homeowner's Association meeting with a limited turnout. City Hand. Belle Isle Officials, Mayor Commissioner Bill Brooks (Mayor elect), Commissioners Sonny Poff, and Trudy Prince attended and answered questions regarding taxes, services, and road construction. Since we had so few in attendance and not enough proxies mailed in, we could not conduct a ballot/vote for electing Windsor Place Homeowners Association Board Members. We only had 41 homes/votes represented and we must have at least 77 to meet the requirement of our By-Laws. Our April meeting raised that figure to a total of 61 votes. The meeting has been continued for one more month to obtain the required quorum. If you have not assigned your proxy and are willing to vote your conviction, please plan to attend the May meeting. This will allow the new board to be elected and to proceed with WPHOA business. My concern is that everyone in the subdivision received a proxy in the mail identifying homeowners that had been nominated; however, very few mailed in the proxy or attended the meetings. We still need 16 votes or proxies to establish a new board or we have to start the election process over. It is your Homeowner's Association, please support it. If you do not have a proxy, contact any board member to obtain a copy.

Homeowner dues are due and payment is required by March 31. Delinquent Dues as of April 1 will accrue interest at the maximum rate allowed by law

#### LAWN WATERING RESTRICTIONS

It is our understanding that Municipalities will be getting strict on violators and we do have violators in Windsor Place. If you are unsure when you are to water your lawn. The schedules are as follows. Water on Wednesdays and Saturdays if your address ends in an odd number. Water on Thursdays and Sundays if you address end in an even number. You may water annuals and new plants with a hose provided it has a restrictor on the end and has a positive cut off as the need arises. These restrictions apply whether you have your own irrigation well or use county water. NO WATERING is allowed between the hours of 10:00A.M. and 4:00 P. M.
