Amended By-law

(Effective May 10, 2001)

Article II, Section 3. Quorum

Except as otherwise provided in these By-Laws, the presence in person or by proxy of the owner

or owners of twenty-five percent (25%) of the lots within the Windsor Place subdivision shall constitute a quorum. The acts approved by a majority of those present at a meeting at which a quorum is present shall constitute the acts of the members, except when approval by a greater number of members

is required by the Declaration or these By-Laws. The joinder of a member in the action of a meeting by signing and concurring in the minutes thereof shall constitute the presence of such member for

the purpose of determining a quorum.

The Windsor Place Homeowners' Association meets monthly at the Hoffner Library. All Windsor Place homeowners are welcome to attend. Signs are posted at neighborhood entrances with date and time prior to meetings.
