

Sidewalks — The Department of Transportation is proposing sidewalks on Limestone Road from Arundel Drive to New Linden Hill Road. The proposed improvements would consist of sidewalks on the northern side of Limestone Road and intersection improvements to enhance pedestrian circulation between Arundel Drive and New Linden Hill Road.



**Deed Restrictions!!** You can now get all deed restrictions from our new web site or from the back of the directory.

#### Deed restrictions of the month:

#8 <u>Vegetable Gardens.</u> No vegetable gardens shall be kept or maintained in side or front yard areas.

#10 <u>Trash Receptacles.</u> Trash receptacles shall be kept in enclosed areas, hidden from view, excepting on regular collection days, when they may be placed temporarily at the curb. Trash must be in covered cans or sealed plastic bags.

#13 <u>Signs.</u> No signs of any nature whatsoever shall be erected, placed or maintained on any lot, except that a single real estate "For Sale" sign may be so placed and maintained.

These restrictions have been copied directly from the Deed Restrictions contract that you attained when you purchased your house in Wood Creek. Over the past several months, it has been noticed that several residents have and are violating these restrictions. Please adhere to Wood Creek Deed Restrictions, it makes our community a much more beautiful one and helps keep property value high. Something we should all be proud of!

**Trash!** If you see trash anywhere in the community, please pick it up. We have a beautiful community, and when there is litter in yards, the front entrance, anywhere, it just makes our community look bad. Please pass along to your family and any of their visitors, please DO NOT LITTER!

Barking Dogs!! If your neighbor's dog's barking is annoying you, it is up to you to have a friendly chat with them. However, after the 10 o'clock evening hour, you can call the New Castle County police and file a compliant.

**Dog Droppings!** Please pick up after your dog and dispose of properly. We have had complaints that some are disposing of droppings in the storm sewers. This pollutes our streams and eventually our drinking water.

**Speeding!** As always, please pay special attention to speeding and other traffic violations in Wood Creek. This is an ongoing problem, hence an ongoing concern. Help keep our neighborhood safe!!

Overhanging Trees! Please keep any trees or shrubs that may be overhanging the road trimmed. Trees that overhang can hit a vehicle's antennas, and may cause them to swerve toward the middle of the road.

# If You Own a House, Mobile Home or Other Structure with Polybutylene Plumbing Purchased After September 12, 1999

## THIS NOTICE MAY AFFECT YOUR LEGAL RIGHTS


f you purchased a house, mobile home or other structure in the United States after September 12, 1999, that contains plumbing composed of polybutylene pipe with plastic or metal insert fittings ("PB plumbing"), this Notice is directed to you. The PB plumbing must have been installed between January 1, 1978 and July 31, 1995.

The \$950 million settlement in Cox v. Shell Oil Company, a national class action on behalf of homeowners who have PB plumbing, provides relief to Class Members with qualifying leaks in PB plumbing that meets certain age restrictions as defined in the Notice of Class Action and Settlement.

If you have PB plumbing, you may be entitled to free replacement of your plumbing if it has leaked in the past, or leaks in the future. If you had a qualifying leak in your PB plumbing, you must complete a Claim Eligibility Form to begin the processing of your claim.

If you do NOT want to remain a Class Member and participate in the benefits of the Settlement ("opt out"), you must complete, sign and return an Exclusion Request as outlined in the Notice of Class Action and Settlement. If you opt out you will not participate in any of the benefits of the settlement or be bound by it.

### **Identifying Polybutylene Pipe**



- PB pipe is a non-rigid, sometimes curved, usually gray (or possibly silver or black) plastic pipe used in water supply plumbing systems.
- PB pipe is blue, gray or black when used in the underground service from the water company.
- PB pipe is not used for drains, waste or vent piping.
- PB pipe is not PVC or CPVC, which is a rigid white or off-white plastic pipe.


