Y2K COMMUNICATIONS TESTING

On Friday, April 9, 1999, Dane County will activate the Emergency Operations Center (EOC) at approximately 10 AM to determine the

reliability of its communications links for use during disasters and communications system outages. This activation will involve public, private, and volunteer agencies. Ham operators are needed for backup communications within the county. **If you would like to participate**, contact Bob Aspinwall, WB9RND, at wb9rnd@arrl.net or call his home at (608) 663-8835. The frequency list outlined below may change to meet the requirements of coordinating agencies in the city and county. The communications links to be tested are as follows:

- 45.320 MHz: Dane County Emergency Management frequency used for siren and EBS/EAS activations. On the same frequency, two-way contact will be established with the State EOC and the American Red Cross, Badger Chapter, with simple, voice test messages.
- 453.925 MHz: (repeater output) Dane County Regional Airport Operations staff.
- 856.xxx MHz: City of Madison radio trunking system, which links the county EOC, the 911 Center, the backup 911 center in Fitchburg, and the City EOC in the event of telecommunications line loss.
- 158.745 MHz: "A" "Adam" VHF, countywide fire/EMS administration channel from our department command vehicle located in downtown Madison. Simple voice test of van radio with 911 center, EOC, and alternate 911 center.
- 155.280 MHz simplex: Interhospital, emergency room backup channel. Links all Madison hospitals with the 911 center and the county EOC.
- VHF or UHF amateur radio repeaters, depending upon desires of the group.

The county EOC links to the American Red Cross, State DEM, mobile or home "command" posts as needed. It would be very desirable to have an amateur radio operator at the state and the county EOC and at the American Red Cross radio room in Madison (Hint: There is no UHF radio in the EOC, but we do have a UHF/VHF antenna and splitter available.) Electric and telephone utilities that service the Metro Dane County area have been invited to test their twoway and other communications channels from the EOC as well. In addition to rf tests, such things as telephone trees, internet, list servers, and fax "broadcasts" will also get a workout. The county EOC will be running on emergency power to fully test communications equipment operation under these conditions. Some communicators from the primary 911 center will be assigned to the county EOC and the alternate 911 center in Fitchburg.

TORNADO DRILL

The statewide tornado drill will be on April 22 from 1 PM to 2 PM. This will run just like a severe weather event. The sirens and weather alert radios will be activated at approximately 1:15 PM. The South Central WI Skywarn net will be activated on the 146.88 repeater for Dane, Columbia, Sauk, Green, Iowa, and LaFayette Counties. Net



control will take check-ins and also advise listeners of what Sullivan National Weather Service (NWS) wants reported during a severe weather event. The 147.150 MARA repeater would be used as the liaison net to Sullivan NWS net control station (NCS). The nets will terminate at approximately 2 PM.

A PROCLAMATION

Whereas, during times of national and state emergencies, amateur radio operators continue to provide communication resources; and

Whereas, these communications resources are provided at no cost to the Wisconsin taxpayers; and

Whereas, there continues to be a need for amateur radio operators to provide emergency communication capabilities as a backup resource during state and national emergencies; and

Whereas, amateur radio organizations such as the Radio Amateur Civil Emergency Services (RACES) and the Amateur Radio Emergency Services (ARES) are organized and trained to provide emergency communication support; and

Whereas, amateur radio clubs throughout the State of Wisconsin provide radio courses of instruction, encourage, and assist with grade school and high school programs about amateur radio, and provide the opportunity to become a licensed amateur radio operator; and

Whereas, amateur radio operators informed the world about Wisconsin's Sesquicentennial, Wisconsin's circus heritage including the Circus World Museum, the Great Circus Train, and the Great Circus Parade; and

Whereas, amateur radio operators, participating in SKYWARN, provide trained and radio equipped severe weather spotters to assist the National Weather Service and the State of Wisconsin;

Now, therefore, I, Tommy G. Thompson, Governor of the State of Wisconsin, do hereby proclaim April 22, 1999

AMATEUR RADIO OPERATOR RECOGNITION DAY in the State of Wisconsin, and I commend this observance to all citizens.



As Time Goes By

John Hicks KA9KYB received a short letter from Phyllis Seibert, who had been going through a box of old photos and found a couple of ancient QSL cards, one belonging to her dad, Millard Loe of Blanchardville, who was W9DZH in the 1920s. His card had a printed one-cent stamp on the back.

The other card (see above) had a picture of a vintage station belonging to Clifford Penniston, W9BQQ. Mrs. Seibert mentioned that BQQ's equipment was more modern at that time than her dad's. She said she could remember her dad calling CQ. Note the straight key and the tapped coil on the right and the headphones in the left foreground.


1948 At the February 17 FLARC meeting, Harry Sellery W9DCQ talked about his experiences on Guam in connection with his work with the U.S. Bureau of Standards. At the May 4 meeting, a motion was passed that the club give \$20 toward the purchase of a canoe for the YMCA camp. On May 18 visitor Gar Lincoln was introduced. At the July 26 meeting, members made plans for a picnic in mid-August at Blue Mounds State Park. Drivers of each car were to leave their name and license number at the park gate so that FLARC could pay their entrance fees. Drawings for prizes would be held at 10:30 AM: a McMurdo-Silver wave meter with coils for 80, 40, 20, and 10 meters would be given to a lucky ham. Prizes for the "lucky" ladies were a 1pound box of candy and a Toni permanent with curlers. Refreshments would be 5 cases of beer and 5 cases of pop. At the August 3 meeting, W9DCQ talked about his experiences with ionospheric measurements and the gear he planned to use at Anchorage, Alaska, in the coming winter.

1949 At the April 19 meeting, business matters were finished by 8:30 PM, and the transmitter hunt began. At 9:30, all those who had not found the transmitter went to the council ring in the UW Arboretum, where a nice warm fire was burning, and refreshments were served. At 10 PM the hidden transmitter crew took off with the remaining refreshments and were later discovered at the WHA transmitter site on Fish Hatchery

Road. By midnight all the food had disappeared, so everyone went home.
