

KAEOPP President's Report February 2006 Greensboro, NC

The National and Legislative Scene:

Recently, the TRiO community received both good and bad news on the legislative scene. First, FY 2006 funding for Talent Search and Upward Bound was restored in late 2005 at the \$836.5 million level. However, after the passing of the Defense Appropriations bill, a 1% across-the-board cut in discretionary spending was passed by Congress, bringing the 2006 TRiO Appropriation to \$828.2 million. It is expected that President Bush will release his budget recommendations for FY 2007 to Congress on February 6.

The Higher Education Act of 1965, which was to expire December 31, 2005, has been extended by Congress until March 30, 2006. While two of Kentucky's Congressmen (Chandler (D) and Whitfield (R)) have graciously signed onto the Cole/Payne letter opposing the 10% Novice Provision of HR 609, we still need the signatures of the following Kentucky Congresspersons:

Please contact your Member today and request that they sign onto the Cole/Payne letter evidencing their support for the elimination of the Novice Provision language and their support for the TRiO Programs.

Continue to encourage your students, their parents, and members of your larger communities to write and call congressional members to voice their concern and support for the TRiO programs. The Talent Search grant competition closed on January 6, 2006, and the deadline for submission of Educational Opportunity Center proposals is February 15, 2006. This round, both programs have utilized or will utilize Grants.gov to submit electronic applications.

KAEOPP News:

The KAEOPP Board and committees continue in the process of updating our current Policy and Procedures Guide, last revised in 1999-2001, to make it more reflective of the Association today. A draft of this revised document is expected to be complete in April 2006.

Fiscal Management Plan:

KAEOPP Treasurer Annette Hines, with guidance from Finance Committee, has developed a Fiscal Policy Manual that outlines fiscal processes and allowable expenditures for the Association. This document will be presented to the Membership for acceptance during the KAEOPP Business Meeting held during the 2006 SAEOPP Conference.

2006 Strategic Summit:

Gregory Marable, Chair of the KAEOPP Strategic Planning Committee, is actively working on developing the KAEOPP Strategic Plan, updating its mission and vision statement, and identifying the core values that uniquely demonstrate KAEOPP's philosophy. The intended outcome of all of these efforts will be to provide a comprehensive structure and plan to provide focus for KAEOPP and to strengthen the Association. Gregory is working with KAEOPP committee chairs to compose goals and objectives for the Association and plans to have a draft Strategic Plan available for KAEOPP's first *Strategic Summit*, which will be held prior to the KAEOPP Spring Meeting at Lake Cumberland State Park on April 24, 2006.

If granted, the Kentucky TRiO Society would received funding to expand its efforts to create a cohesive association of alumni of our Kentucky TRiO programs and offer opportunities for alumni to become actively involved in KAEOPP (enhancing the financial stability of the Association), in networking, and in advocating on behalf of our programs and current participants.
